6	GCC 41: Payments	<p>For providing payment security and making payment to Contractor, following options shall be used based on the mutual agreement between the Authority and Contractor:</p> <ol style="list-style-type: none"> 1. The payment can be made based on the invoices raised by the Contractor 2. The payment can be routed through ESCROW account where funds are held until it receives the appropriate written instruction from ASCL for Implementation phase and from MCA for O&M phase. <p>The Successful Bidder shall raise invoices on achieving each milestone and submit three copies of same (one each to ESCROW bank, one for Authority & MCA). The concerned Authority will review the invoice and approve the same after adjusting for applicable penalties. The payment will be processed as per ASCL/ MCA's procedure. The ESCROW bank upon receipt of written approval of the invoice by ASCL/ MCA shall undertake use of the money deposited in the ESCROW account to pay against the invoices and O&M Fee.
